The completed application SIGNED BY BOTH OF YOUR SPONSORS who must be present Corporate members of at least 2 years standing and a \$812.81 (includes tax) check payable to RC.Y.C., Inc. to cover the initiation fee (not applicable to Junior and Intermediate applicants) should be forwarded to:

You are required to have each of your sponsors complete the Proposer/Secunder Statements and submit them without your application. After application, check and sponsor forms have been received, you will be contacted by a member of the Membership Committee who will arrange a meeting with you and your spouse to discuss details of the Club, explore your interest in boating and answer any questions you may have concerning membership.

Annual Dues based upon class or membership is as follows:

REGULAR		$\$950.00 + 8.375\% \text{ tax} = \1029.00
INTERMEDIATE	25 through 29	75% of Regular Dues = $\$712.50 + \$59.68 = \$772.18$
	18 through 24	50% of Regular Dues = $\$475.00 + \$39.79 = \$514.79$
Junior	12 through 17	10 % of Regular Dues = $\$95.00 + \$7.96 = \$102.96$

Annual Assessments

There are annual assessments that are billed each year in addition to your dues:

- a) Capital Improvement Fund is \$95.00 plus tax.
 - b) Dock Improvement Fund is \$50.00 plus tax.
 - c) Capital Improvement is \$120.00 plus tax.
- **Dock Replacement Fund 9/26/06 is \$300.00 plus tax (1 time only fee).

In addition, each Regular Member (Junior and Intermediate Member excluded) is required to post a \$400.00 Capital Improvement Bond, which is to be paid in full when joining. The nature and terms of the refund of this Bond will be part of your discussion with the Membership Committee.

Richmond County Yacht Club has a fine tradition of yachting and social activities and its members are justly proud of their Club and its facilities. We are pleased you have elected to join with us and look forward to receiving your application and meeting you.
