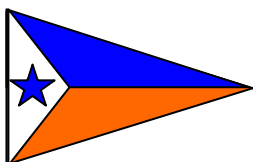

Above all, he never allowed his disease to become an obstacle for living life abundantly. He always found a way to look forward, and taught us all perspective.

Rules: The Regatta will be governed by the 2009-2012 Racing Rules of Sailing and the Poco Loco Bay Race Sailing Instructions.

Eligibility and Entry: The Entry Fee is \$85. The Regatta is opened to all PHRF-MA members for the Spinnaker and Non-Spinnaker Divisions, NEMA members for the Multihull Division, and open to all boats for the Cruising Division. Please send a copy of your PHRF-MA or NEMA rating certificate with your entry form. Pre-Registration is open from June 1, 2010 to September 22nd, 2010 and can be mailed to William Scalisi, 142 Kingdom Ave, Staten Island, NY, 10312 646-251-4013. If you cannot register the morning of the regatta before the Skippers Meeting at Richmond County Yacht Club, you **MUST** Pre-Register. Entrants in the Spinnaker and Non-Spinnaker Divisions will qualify for the New Jersey Ocean Racing Conference (NJORC) Series.

Sailing Instruction: The Sailing Instructions will be available at registration the morning of the regatta at Richmond County Yacht Club and on the web at <http://rcyachtclub.org/pocobayrace.htm>.

Classes: There will be a Spinnaker Division (A), a Non-Spinnaker Division (B), a Multihull Division (M), and Cruising Division (C). Sub-Divisions will be created based on the number of applicants in the divisions.
